**Call to Order/Ethics Awareness/ and Introductions:** Vice Chair Guess called the meeting to order at 2:30 PM and welcomed all present. Introductions were conducted, followed by the Introduction of online viewers.

**Approval of Remote Participation:** Online attendees were Stephan Sparks, Wendy Cato, Glen Harvey, Hannah Smith, Jordan Powell, Holly Crafton-Lay and Meagan Phillips. Vice Chair Guess canvassed the committee for any objections to online participants. Upon a motion made by Mr. Simms and seconded by Mrs. Patton, online participation was approved.

# Action Items: Action Items:

- **I. Approval of Consent Agenda:** Vice Chair Guess called for a motion to approve the consent agenda. Upon a motion from Mrs. Patton and a second from Mr. Johnson, the Committee unanimously voted to approve the consent agenda.
- II. Board Officer Elections: The committee conducted elections for Chair and Vice Chair in accordance with the bylaws, which require elections every two years. Nominations were opened for the position of Chair, and Mayor Hank Guess was nominated by Mrs. Beatty and seconded by Mr. Morrow. A vote was held, and Mayor Guess was elected by majority vote. Nominations were then opened for the position of Vice Chair, and Bruce Eckard was nominated by Mr. Townsend and seconded by Mr. Johnson. A vote was conducted, and Mr. Eckard was elected by majority vote.
- III. Open LAPP Call for Projects & Release Methodology Revisions: Mr. Odom presented the Local Administrative Project (LAP) program call for new projects and supplemental requests. The Greater Hickory MPO has \$4.6 million in federal funding available this year for eligible locally administered projects, including bicycle, pedestrian, intersection, and transit improvements. The call for projects opens on March 26, with applications due May 2, initial scoring on May 28, and final approvals on June 25. He also requested that TCC and TAC consider removing the Transportation Disadvantage Index and bicycle-centric language from the LAP methodology to align with evolving USDOT funding priorities, with these changes open for public comment before April approval.
- IV. Draft Western Piedmont Transportation Safety Plan: Mr. Powell presented the draft Western Piedmont Safety Plan, developed over 12 months, with a goal to eliminate fatalities and serious injuries by 2050 and reduce them by half by 2035. The plan outlines five foundational goals, a crash reduction framework, and implementation tools, including location screening and a safety prioritization dashboard. He also discussed the upcoming Safe Streets for All (SS4A) funding opportunity, with applications expected to open by March 31 and close in June. The plan positions the region to pursue funding, with a focus on roadway and rural safety projects, and the MPO may batch applications for multiple

- jurisdictions. Office hours are scheduled for April 7 and 9 to assist members with applications.
- V. 2025 MPO Meeting Schedule Modification: Ms. Ritchie presented a modification to the existing MPO Schedule. The modification was regarding a change of date for the MPO Meeting from April 23<sup>rd</sup> to April 30<sup>th</sup>, 2025. Upon a motion made by Mr. Johnson and a second by Mrs. Beatty, the MPO Meeting Schedule Modifications were approved.

#### NCDOT Update -

- **NC DOT Board:** Mr. Lail presented an update on Hurricane Helene recovery, noting \$5 billion in damages to state roads, primarily in Divisions 11, 13, and 14, with FEMA expected to cover 80% of costs, leaving a \$1 billion state funding gap. To address future risks, the NCDOT Board is developing a resiliency subcommittee to strengthen infrastructure against natural disasters.
- Division 11: Mr. Poe presented an update on disaster recovery and ongoing transportation projects, noting approximately \$280 million in estimated storm damage costs within the division, with Caldwell County 60% complete in site-specific repairs. Key project updates included the Brown Mountain Beach Road project now under construction, delays in U-4700 CA and CB due to utility relocation issues, and U-6157 progressing with right-of-way acquisition. Additionally, federal funding adjustments required revisions for U-6034, with right-of-way acquisition expected to begin in late spring or early summer. He also noted upcoming interstate mowing operations and ongoing resurfacing initiatives.
- **Division 12:** Mr. Stafford provided project updates within the agenda packet for Division 12 & Division 13. Mr. Stafford presented an update on maintenance operations, noting that interstate mowing will begin next week, followed by county roads once interstate work is complete. The spring litter sweep is scheduled for April 12–26, with contract provisions ensuring litter removal before mowing. He confirmed that project schedules, including First and Second Avenue improvements, remain on track.
- **Division 13:** Mrs. Smith presented an update on Burke County projects, noting that the active construction progress report is included in the Division 12 report. She confirmed that there are no updates to the Burke County STIP program since the last meeting. She introduced NCDOT's Toll Credit Pilot Program, which allows local governments with TAP-funded LAP projects to apply for toll credits to cover the non-federal match, though only two projects in the MPO may be eligible. The application window is open from March 31 to May 31, and staff discussions may be necessary.
- Mr. Anderson presented an update on storm recovery efforts, stating that debris
  removal in Burke County is progressing well, with the county requesting NCDOT
  assistance on primary routes. Interstate debris removal is nearly complete, with only
  remaining leaners and hangers to be addressed. He noted efforts to synchronize
  mowing schedules and acknowledged the upcoming hurricane season as a reminder of
  the importance of continued preparedness.

•	NCDOT-TPD: Mr. Crummy addressed the Board adoption of the CTP plan for the MPO,
	stating that it is under review now for approval. Mr. Crummy also referenced a link to
	IMD quarterly update videos that he will provide.

• **NCDOT-IMD:** No updates

• **FHWA:** No updates

**Reminders:** Ms. Ritchie reminded members about three key items: the new member orientation for TCC and TAC members on April 30th, with one-on-one meetings available for those who missed it; the SEI and RED filing deadline on April 15th, offering assistance for anyone needing help with filing; and the importance of discussing the SS4A funding source with TCC members, with workshops on April 7th and 9th available both in-person and virtually.

Modifications and revisions often include funding and fiscal year changes. Revisions are released monthly by NCDOT.

### TOWN of VALDESE

#### RESOLUTION

Resolution to withdraw the Lovelady Rd. Sidewalk Phase I Project, BL-0140A, from the Statewide Transportation Improvement Plan

**WHEREAS**, the Greater Hickory Metropolitan Planning Organization (GHMPO) issued a call for projects to agencies in its jurisdiction for Locally Administered Projects Program (LAPP); and

WHEREAS, the Town of Valdese submitted an application and funding was programmed for Preliminary Engineering, Right-of-Way & Utility Acquisition, and Construction for a curb and gutter sidewalk along Lovelady Rd. Valdese starting at Laurel St. NE and ending at Crescent St NE, identified as BL-0140A in GHMPO's Transportation Improvement Plan (TIP); and

**WHEREAS**, the Town of Valdese has determined that the sidewalk required by the LAPP Grant is cost prohibitive both as a singular project as well as it being cost prohibitive overall to the Town budget due to other competing projects which rose in costs; and

**WHEREAS,** the Town of Valdese is returning \$1,144,800 in Surface Transportation Block Grant – Direct Attributable (STBG-DA) funds to GHMPO's LAPP discretionary funding.

**NOW, THEREFORE, BE IT RESOLVED,** the Town of Valdese Town Council requests that the Western Piedmont Council of Governments withdraw the Lovelady Rd. Sidewalk Phase I Project, BL-0140A, from the Statewide Transportation Improvement Plan.

### **SUMMARY OF REQUEST:**

Each year, the WPCOG and GHMPO assesses dues to its local governments per its charter and bylaws. The TAC approved the FY26 Assessments at its meeting in January.

The approved assessments included temporary assessments for funding regarding the WNC Passenger Rail Project to fund our region's share (\$50,000) for the non-federal match for the service development plan. The NC Department of Transportation informed our transportation planning staff that it will provide the non-federal match for the service development plan. As a result, assessing our local governments for the \$50,000 match in FY26 is no longer necessary.

Future local matching funds may be required for this rail project but details are not currently available.

The attached table shows revised assessments.

**WHEREAS,** the TAC acknowledges the collaborative efforts of local governments, stakeholders, transportation professionals, and the public in shaping the WPTSP to reflect regional needs and priorities;

**NOW,** THEREFORE, BE IT RESOLVED, that the Transportation Advisory Committee hereby adopts the Western Piedmont Transportation Safety Plan as the guiding document for regional transportation safety planning and improvement efforts.

### **SUMMARY OF REQUEST:**

On January 31, 2025, the State Transportation Improvement Program (STIP) Unit of NCDOT released the draft 2026–2035 STIP. Since then, MPO staff have been working closely with local governments, NCDOT Division staff, and the STIP Unit to evaluate a range of scenarios aimed at improving the timeliness and financial feasibility of project delivery.

To address delays associated with project R-3430C, NCDOT has proposed segmenting the project—specifically, advancing the portion from Cajah's Mountain Road to Southwest Boulevard. This segmentation is expected to accelerate the delivery of that northern segment. Under this proposal, the southern portion of the project, from Cajah's Mountain Road to the Catawba River, would remain fully committed but is expected to continue on the current draft STIP timeline. As it stands, right-of-way acquisition is scheduled for 2030, with construction slated to begin in 2034.


The overall project will widen Connelly Springs Road to a four-lane facility and includes the potential for bike and pedestrian infrastructure along both proposed segments.

MPO and NCDOT staff have coordinated with Caldwell County and the Town of Cajah's Mountain, and all parties have expressed strong support for advancing the project as efficiently as possible.

A map illustrating the proposed project segmentation is attached for reference.

# RESOLUTION OF SUPPORT FOR PROJECT SEGMENTATION OF R-3430C – CONNELLY SPRINGS ROAD IMPROVEMENTS

WHEREAS, the North Carolina Department of Transportation (NCDOT) released the draft 2026–2035 State Transportation Improvement Program (STIP) on January 31, 2025; and

WHEREAS, staff of the Greater Hickory Metropolitan Planning Organization (MPO) have actively coordinated with local governments, NCDOT Division staff, and the STIP Unit to assess project delivery scenarios that support the timely and financially feasible implementation of transportation improvements; and

WHEREAS, to address delays associated with project R-3430C, which proposes the widening of Connelly Springs Road to a four-lane roadway, NCDOT has recommended segmenting the project into two phases—one from Cajah's Mountain Road to Southwest Boulevard and the other from Cajah's Mountain Road to the Catawba River; and

WHEREAS, this proposed segmentation is expected to expedite the delivery of the northern segment of the project (Cajah's Mountain Road to Southwest Boulevard), while the southern segment remains committed and continues on its current STIP timeline, with right-of-way acquisition in 2030 and construction beginning in 2034; and

WHEREAS, the project includes potential enhancements for bicycle and pedestrian infrastructure, contributing to a safer and more multimodal corridor; and

WHEREAS, MPO staff and NCDOT have met with representatives from Caldwell County and the Town of Cajah's Mountain, all of whom support efforts to advance the project as efficiently as possible;

NOW, THEREFORE, BE IT RESOLVED, that the Transportation Advisory Committee of the Greater Hickory MPO hereby expresses its support for the proposed segmentation of Project R-3430C and encourages all involved parties to continue working collaboratively to expedite its delivery and maximize its regional transportation benefits.

- Preliminary Motor Fuels Tax (MFT) Consensus Forecast for Governor's Budget (January)
  - January forecast assumptions Population grows roughly 1.15% a year;
     Vehicle Miles Traveled (VMT) grows 1.5%-2.0% a year; Tax rate fluctuates with economy.
  - Forecast Update Consumer confidence is declining. Fuel economy was anticipated to improve but tariffs and Electric Vehicles (EV) changes will slow lower projections
- Preliminary Highway Use Tax (HUT) Consensus Forecast for Governor's Budget (January)
  - o January forecast assumptions- Strong inventories for new vehicle prices remain at record highs; EV sales grew 15% year over year.
  - Forecast Update Tariffs will create market instability; manufacturers will cut production; layoffs may ensue; and analysts estimate a \$12K increase in new personal vehicle prices. Commercial vehicle sales are likely to be significantly impacted
- Preliminary Department of Motor Vehicle (DMV) Consensus Forecast for Governor's Budget (January)
  - January forecast assumptions DMV fees remain steady and quadrennial reset occurred on July 1, 2024.
  - o Forecast Update Title fee revenues will decline. Federal EV tax credits eliminated; pause on National Electronics Vehicle Infrastructure (NEVI) program, and policy changes to the USDOT fuel economy standards (CAFÉ) and EPA emissions standards will affect vehicle sales. Due to tariffs and other policies from the current administration, vehicle production could drop by as much as 30% by 2027.

Jeremy A. Goodwin, PE -State Roadside Environmental Engineer

The NCDOT Wildflower Program History

#### It started with a letter

o In 1982, First Lady Dottie Martin, wife of Governor Jim Martin, envisioned the NC Wildflower Program when she read an article in the Wall Street Journal and asked, "What can we do to get this sort of thing going in N.C.?". Shortly afterwards, the Wildflower program was created in 1985.

### Funding

Landscaping funds were not available when the Wildflower Program began.
 Part of the \$1.2 -\$1.4M Personalized License Plate Program funds help the wildflower program.

### History

- o The Wildflower Program began on twelve acres. When it started, there were no vendors for this project. NCDOT in the late 1980s started working with nurseries for the project. During the first three years, not a lot was occurring. NCDOT planted seeds and soil, and it was a tough time getting it started. It was also very labor intensive, but after the first three years NCDOT began seeing progress.
- The Garden Club of North Carolina continues to be the lead sponsor of the Wildflower Program. Other important partners like Coca-Cola, NC State University, North Carolina Department of Agriculture, Consumer Services, and Bayer CropScience have also been sponsors of the program.
- o In 2007, The Garden Club came together to participate in judging Division Wildflower beds. There were many awards for this program including best photos, best color etc. The Garden Club with their master judges have gone through several hours of training to judge this program across the state.
- o Currently, NCDOT has 609 beds of wildflowers totaling 738 acres. Among the flowers planted are North Carolina native species; Clasping Coneflower, Bur-

- Marigold (Bidens), and Maximilian Sunflower. Due to Hurricane Helene, things have slowed down a bit this year.
- o This program is one of NCDOT's most popular initiatives and receives hundreds of letters, notes, and comments from across the state on the flower beds and the program. NCDOT gets a lot of accolades from the public and visitors in the state with letters from citizens who appreciate the program along with donations which are unsolicited. The program brings together endless roads of color.

### Helping Pollinators

- Research has shown that when compared to non-mown rights-of-way, wildflower beds have:
  - 6 times more pollinator bees
  - 2.5 times more pollinator flies
  - 5 times more pollinator butterflies
  - 37 times more pollinator wasps
- In 2015, the program received a \$150,000 donation from Bayer CropScience for pollinator habitat plantings. Wildflower beds are a great habitat for pollinators

### • What does it take to develop a Wildflower bed site

- o The route must be highly traveled
- o The site targeted is an acre or more
- o Safety so that staff can go out and maintain them
- o Best results for fertilizing the beds
- The cost of the weed management for the Wildflower beds is about \$2000-\$3000

#### Daylily Beds

- o At one point, 2.5M Daylilies were planted throughout the state. The intent was to provide a pop of color during the summer months.
- o Initially, these plants were very labor intensive to manage, now they plant themselves.
