#### 5. Financial Plan

Federal law (23 USC 134) requires the 2045 MTP to be fiscally-constrained. This requires that the cost of all recommended transportation projects be covered by all transportation revenues reasonably expected to be available during the 30-year period of this plan. The Financial Plan provides a comparison of expected revenues and costs from 2018 through 2045.

The 2045 MTP divides projects into three time periods:

- 2018 to 2025 = Horizon-Year 2025
- 2026 to 2035 = Horizon-Year 2035
- 2036 to 2045 = Horizon-Year 2045

Revenue for the MTP was projected by taking the average of total regional funding in the first five years of the current TIP (FY 2018-2027), then growing that average annually by 3% for each subsequent year. Using this projection as a fiscal constraint, the full MTP project recommendations must total less than the following amounts:

- \$ 918,659,530 = Horizon-Year 2025 (2018-2025)
- \$1,266,450,173 = Horizon-Year 2035 (2026-2035)
- \$1,745,909,109 = Horizon-Year 2045 (2036-2045)
