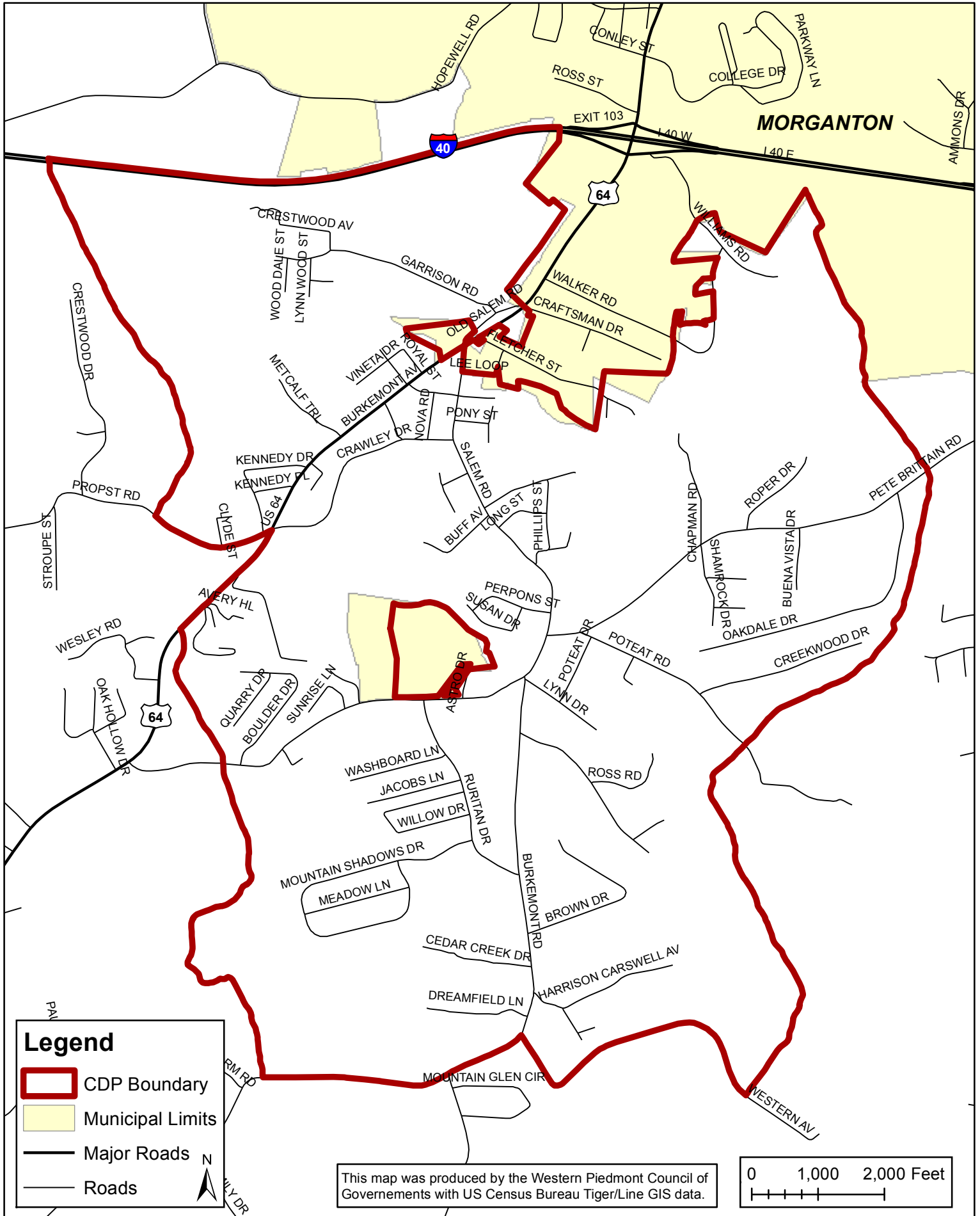


Salem Census Designated Place (CDP)
