AAA has a duty to monitor all services in Alexander, Burke, Caldwell and Catawba counties funded through the Home and Community Care Block Grant (HCCBG), Legal Services and Family Caregiver Support (FSP) according to the standards and policies set by the NC Division of Aging and Adult Services. Providers are monitored at least every three years or more frequently based on their annual risk assessment.

AAA staff recently completed their monitoring for FY 2015-16. This year's monitoring included 16 HCCBG services provided by 12 different providers and 3 FSP services provided by 3 separate providers. During monitoring visits, AAA staff review temperatures of home-delivered and congregate meals, client files, driver logs, attendance records, meal delivery records, volunteer and staff training records, contracts, financial audits and records, receipts, budgets, inspections, sanitation ratings, etc. Upon completion of the monitoring visit, AAA sends the provider and county manager a complete assessment report detailing all findings from the visit.

### Primary Income Demographic Data Report


