PURPOSE: To establish an official method of issuing and disseminating Western

> Piedmont Workforce Development Area's (WPWDA) procedural, administrative, management and program directions to WPWDA Title I Contractors (herein referred to as Contractors). To rescind WPWDA

Policies/Procedures Policy Statement dated July 1, 2015.

BACKGROUND: The WPWDA has local responsibility for the Federal Workforce

Innovation and Opportunity Act (WIOA) and in that capacity offers direction and guidance in reference to those funds and interactions with US Department of Labor's Employment and Training Administration as well as NC Department of Commerce, Division of Workforce Solutions.

Policy/Procedural direction will be provided to Contractors in several ways:

- (1) Through WPWDA Policy Statements
- (2) Through the Contract document
- (3) Through the Request for Proposal (RFP) process

Until further notice, Contractors are to follow WPWDA policy statements PROCEDURE:

that have been established to date and are addressed in (2) and (3) above. WPWDA policies will be modified as needed. Issues not yet addressed by WPWDA will be governed by Local Area policies that are presently in effect. Contractors identifying existing policy, which may conflict with WIOA should bring this to the attention of the Workforce

Development Program Administrator.
