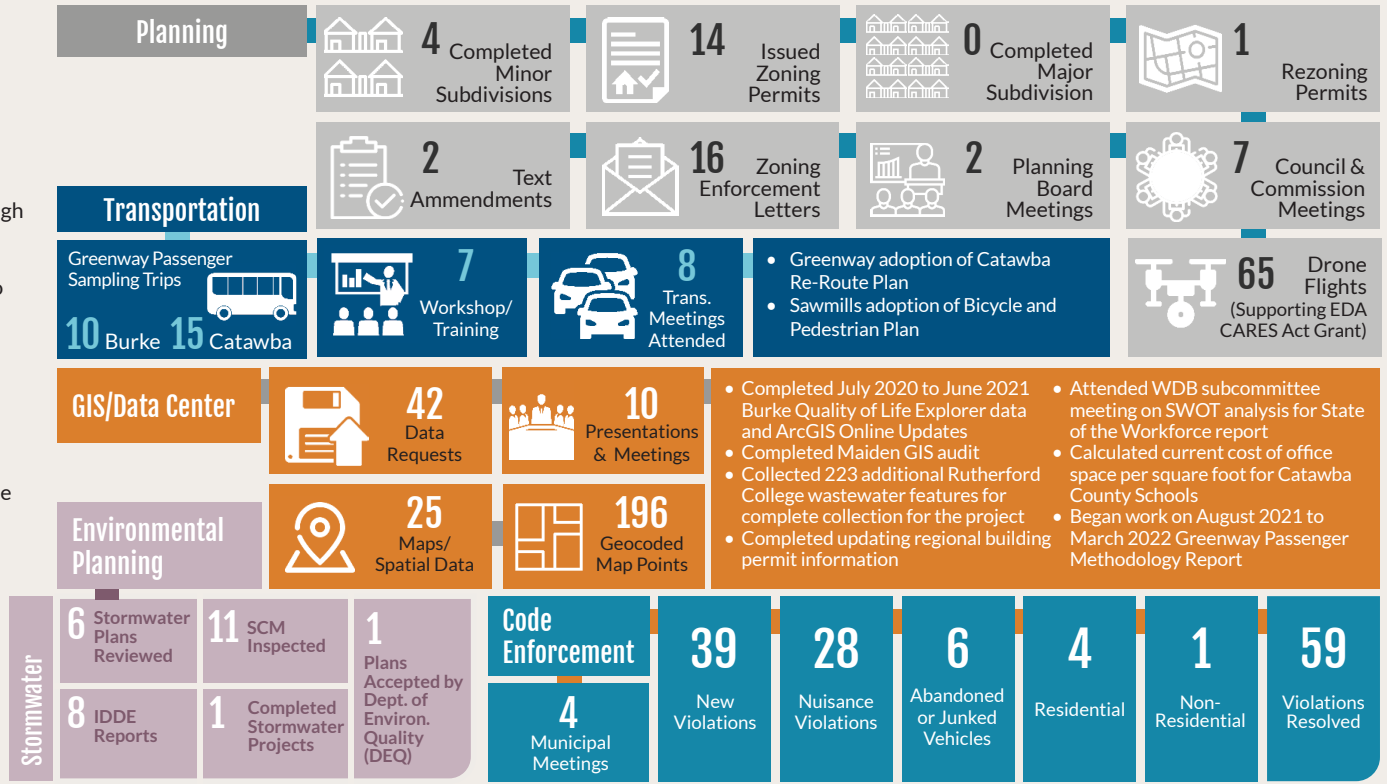

Funds pay for counseling services, but not rental or mortgage assistance. Staff submitted two N.C. Commerce Building Reuse Grant applications totaling \$875,000. Project Husky II located in Burke County requested \$500,000 and will create 60 new, full-time jobs. Project Wavelength, in Catawba County, requested \$375,000 and will create 50 new, full-time jobs. Staff is working on two ARC applications - The Hudson and Valdese Economic Development Investment Corporation (VEDIC). Applications due July 30, 2021. 			

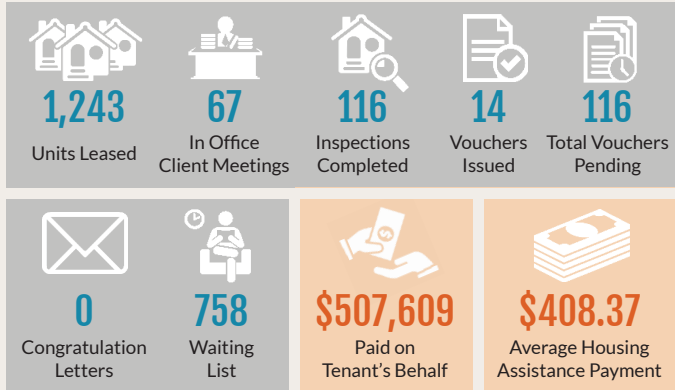

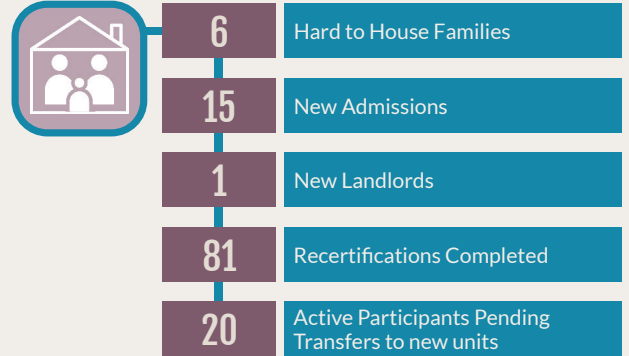

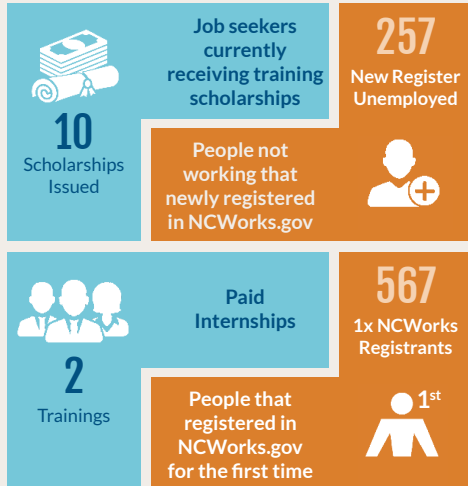
